**Q:** I'm a municipal manager and in talking with some colleagues recently, I learned there is now a waitlist for energy efficiency programs. What's the story?

A: Due to high demand, there is a waitlist for all government, nonprofit, and education customer programs through May 2021. Existing reserved projects and complete pre-approval applications that were received on or before Dec. 31, 2017 will be eligible for rebates. We encourage all customers in this category to continue to send pre-approval applications for projects that will be completed before May 31, 2021 and that are eligible for rebates. Waitlisted projects aren't guaranteed funding, but will be the first considered if additional funding becomes available. Questions? # **Direct Discount Energy** Efficiency Program Update

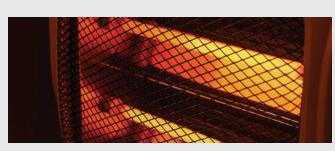
In our continuing effort to assist our small business customers, as of January 1, 2018, the annual usage cap has been lifted and the Direct Discount incentive will increase from \$0.13/kWh to \$0.15/kWh. All GS1 and GS3 rate code customers are eligible and must use an approved participating contractor. There hasn't been a better time to take advantage of incentives to install energy saving projects including lighting, refrigeration and compressed air for your business. ## Cold weather safety tips: Space heaters

Space heaters are popular and helpful, but if not used properly they can present fire and electrical shock hazards, according to the Electrical Safety Foundation International.

ESFI offers numerous tips on space heater use, including:

- · Plug space heaters directly into a wall outlet. Do not use an extension cord or power strip, which could overheat and result in a fire. Do not plug any other electrical devices into the same outlet as the heater.
- · Place space heaters on level, flat surfaces. Never place heaters on cabinets, tables, furniture, or carpet, which can overheat and start a fire.
- · Inspect heaters for cracked or broken plugs or loose connections before each use. If frayed, worn or damaged, do not use the heater.
- · Never leave a space heater unattended. Turn it off when you're leaving a room or going to sleep, and don't let pets or children play too close to a space heater.

#### Giving back to the communities we serve

The PPL Foundation late last year awarded major grants to support 16 organizations working to empower the communities they serve. Earlier in 2017, the foundation distributed smaller sustaining grants to more than 70 community groups.
