Results of Request for Proposals Process – October Solicitation

Dear Mr. Russell:

On October 21, 2009, PPL Electric Utilities Corporation (PPL Electric) filed the results of its Request for Proposals (RFP) Process and Rules (October Solicitation), including the proposed bid results for provider of last resort service for all Residential and Small Commercial and Industrial Customers electing to receive default service from PPL Electric beginning January 1, 2011, at Docket No. P-2008-2060309. The October Solicitation includes results for three RFPs: a full requirements RFP, a block energy RFP, and an alternative energy credits (AEC) RFP. All RFPs apply to the eight month supply period starting on January 1, 2011 and ending on August 31, 2011.

This filing is submitted in accordance to the RFP Process and Rules filed by PPL Electric on July 1, 2009. The RFP Process and Rules were filed pursuant to the Commission's Opinion and Order, entered June 30, 2009, at Docket No. P-2008-2060309.

PPL Electric requests that the Commission approve the bid results from the October Solicitation on or before October 22, 2009.

Further investigation does not appear to be warranted at this time, since the bid results from the October Solicitation appear to have been conducted in accordance with the RFP Process and Rules, filed pursuant to the Commission's Opinion and Order. However, the Tier I Photo-Voltaic AEC RFP was non-competitive.

Therefore, we approve the following bid results submitted for the October Solicitation: the Residential and Small Commercial and Industrial full requirements RFPs, the block energy RFP, the Tier I AEC RFP, and the Tier II AEC RFP. However, we reject the bid results for the Tier I Photo-Voltaic AEC RFP.
