On April 30, 2014 PPL Electric Utilities Corp. (PPL) filed the results of its Request for Proposals (RFP) process and rules, including the proposed bid results from the April 29, 2014 RFP procurement process for provider of last resort for all Residential and Small C&I customers electing to receive default service from PPL during the twelve month period June 1, 2014 to May 31, 2015, all Residential and Small C&I customers electing to receive default service from PPL during the nine month period September 1, 2014 to May 31, 2015, and all Large C&I customers electing to receive default service from PPL during the twelve month period June 1, 2014 to May 31, 2015, at Docket No. P-2012-2302074.

This filing is submitted in accordance to the RFP Process and Rules filed by PPL Electric on May 1, 2012. The RFP Process and Rules were filed pursuant to the Commission's Opinion and Order, entered January 24, 2013, at Docket No. P-2012-2302074.

PPL Electric requests that the Commission approve the bid results from the April 2014 Solicitation on or before May 1, 2014.



In addition, we direct PPL Electric to disclose the results of the April 2014 Solicitation in accordance with the Commission's Secretarial Letter in Re: Disclosure of Default Service Solicitation Results and Creation of a Default Service Rate Calculation Model, issued October 12, 2010 at Docket No. M-2009-2082042.
