Process for the October 2014 RFP.

Dear Mr. Russell:

On October 23, 2014, the Commission issued a Secretarial Letter approving the bid results submitted for the October 2014 RFP process for all Residential and Small C&I customers electing to receive default service from PPL during the twelve month period December 1, 2014 to November 30, 2015, and all Residential and Small C&I customers electing to receive default service from PPL during the nine month period March 1, 2015 to November 30, 2015, at Docket No. P-2012-2302074. For the reasons discussed below, with this Secretarial Letter, the Commission supersedes, in part, the October 23, 2014, Secretarial Letter and approves the corrected bid results submitted by PPL for the October 2014 RFP process for all Small C&I customers electing to receive default service from PPL during the twelve month period December 1, 2014 to November 30, 2015 and for the nine month period March 1, 2015 to November 30, 2015, at Docket No. P-2012-2302074.

On October 22, 2014 PPL Electric Utilities Corp. (PPL) filed the results of its Request for Proposals (RFP) process and rules, including the proposed bid results from the October 21, 2014 RFP procurement process for provider of last resort for all Residential and Small C&I customers electing to receive default service from PPL during the twelve month period December 1, 2014 to November 30, 2015, and all Residential and Small C&I customers electing to receive default service from PPL during the nine month period March 1, 2015 to November 30, 2015, at Docket No. P-2012-2302074.

This filing was submitted in accordance to the RFP Process and Rules filed by PPL Electric on May 1, 2012. The RFP Process and Rules were filed pursuant to the Commission's Opinion and Order, entered January 24, 2013, at Docket No. P-2012-2302074.

PPL Electric requested that the Commission approve the bid results from the October 2014 Solicitation on or before October 23, 2014. On October 23, 2014, the Commission issued a Secretarial Letter approving the bid results submitted for the October 2014 RFP process for all Residential and Small C&I customers electing to receive default service from PPL during the twelve month period December 1, 2014 to November 30, 2015, and all Residential and Small C&I customers electing to receive default service from PPL during the nine month period March 1, 2015 to November 30, 2015, at Docket No. P-2012-2302074.

Subsequently, on October 24, 2014, the PPL Electric RFP Manager, NERA Economic Consulting, informed the Commission that incorrect bids were used by the RFP Manager in evaluating the RFP results for the Small C&I 12-Month (Fixed Price) and Small C&I 9-Month (Fixed Price) products. On the same day, PPL Electric submitted the corrected bid results for the Small C&I 12-Month (Fixed Price) and Small C&I 9-Month (Fixed Price) products. No other product results were impacted or modified by this submission and the results for those products stand as approved by the October 23, 2014 Secretarial Letter.


Further investigation does not appear to be warranted at this time, since the corrected bid results from the October 2014 Solicitation appear to have been conducted in accordance with the RFP Process and Rules, filed pursuant to the Commission's Opinion and Order.

Therefore, we approve the corrected bid results submitted for the October 2014 RFP process for all Residential and Small C&I customers electing to receive default service from PPL during the twelve month period December 1, 2014 to November 30, 2015, and all Residential and Small C&I customers electing to receive default service from PPL during the nine month period March 1, 2015 to November 30, 2015, at Docket No. P-2012-2302074.

In addition, we direct PPL Electric to disclose the corrected results of the October 2014 Solicitation in accordance with the Commission's Secretarial Letter in Re: Disclosure of Default Service Solicitation Results and Creation of a Default Service Rate Calculation Model, issued October 12, 2010 at Docket No. M-2009-2082042.
